Greenery Limited ("Greenery") is indirectly owned by a trust in which Mr. Arnold Ip Tin Chee is one of the beneficiaries. Accordingly, Mr. Arnold Ip Tin Chee has a deemed interest in the Units owned by each of Greenery.

Japan Opportunities Fund Limited ("JOF") was entitled to receive 17,572,213 Units from Central-Top Properties Ltd ("CTPL") on 21 October 2008 as repayment of a loan from JOF to CTPL, after the release of such Units from a moratorium previously imposed on the Units. JOF had in turn declared a distribution of the 17,572,213 Units which it was entitled to receive to its shareholders on 21 October 2008 as a distribution of capital by JOF to its shareholders.

Greenery is one of the shareholders of JOF, and was entitled to a distribution in specie of 205,523 Units by JOF to Greenery on 21 October 2008 as a distribution of capital to the shareholders of JOF. Greenery had in turn instructed Starich Resources Limited ("Starich") on 21 October 2008 to hold on Greenery's behalf the 205,523 Units which Greenery was entitled to receive from JOF.

The 205,523 Units were therefore transferred by CTPL directly to Starich on 21 October 2008, and are held by UOB Kay Hian, as the depository agent of Starich.

Mr. Arnold Ip Tin Chee's deemed interest in the Units owned by Greenery and held by UOB Kay Hian, as the depository agent of Starich (which in turn holds the Units for Greenery) has increased by 205,523 Units from 0 Units to 205,523 Units upon JOF's declaration of the distribution of the 205,523 Units to Greenery.

Starich, as the holder of the 205,523 Units on behalf of Greenery, is also deemed to be interested in the 205,523 Units which is owned by Greenery. Starich is indirectly owned by a trust in which Mr. Arnold Ip Tin Chee is one of the beneficiaries, therefore Mr. Arnold Ip Tin Chee is also deemed to be interested, through Starich in the 205,523 Units owned by Greeneryand held by UOB Kay Hian, as thedepository agent of Starich, for Starich (which in turn holds the Units for Greenery).
