Berggruen Holdings Limited ("BHL") is the beneficial holder of more than 20.0% of the issued share capital of Japan High Yield Property Fund (II) Limited ("JHYP II"). MTL holds more than 50.0% of BHL. Accordingly, MTL has a deemed interest in the Units owned by BHL and held by Raffles Nominees (Pte) Ltd. ("Raffles Nominees"), as depository agent of BHL, as well as a deemed interest in the Units owned by JHYP II and held by UOB Kay Hian Pte Ltd ("UOB Kay Hian"), as depository agent of JHYP II.

JHYP II has transferred 12,959,940 Units to its shareholders on 26 February 2009 as a distribution of capital, after the release of such Units from a moratorium previously imposed on the Units. As such, MTL's deemed interest in the Units owned by JHYP II and held by UOB Kay Hian, as depository agent of JHYP II, has decreased by 12,959,940 Units from 12,959,940 Units to 0 Units.

Further, BHL is a shareholder of JHYP II and has received 5,222,229 Units from JHYP II pursuant to JHYP II's distribution of capital to its shareholders. Accordingly, MTL's deemed interest in the Units owned by BHL and held by Raffles Nominees, as depository agent of BHL, has therefore increased by 5,222,229 Units from 13,595,458 Units to 18,817,687 Units.
