## DIVESTMENT OF KINYACHO GRANDE

---

The Board of Directors of Japan Residential Assets Manager Limited, the manager ("**Manager**") of Saizen Real Estate Investment Trust ("**Saizen REIT**"), wishes to announce the divestment of Kinyacho Grande (the "**Current Divestment**") from the property portfolio of Yugen Kaisha ("**YK**") Shintoku.

### **Background**

YK Shintoku has, on 8 March 2011, entered into a sale and purchase agreement for the divestment of Kinyacho Grande ("**KG**") to an independent private investor (the "**KG Buyer**") for a cash consideration of JPY 390,000,000 (S\$6.0 million<sup>1</sup>) (the "**KG Sale Price**"). The divestment of KG was completed on the same day upon the payment of the full amount of the KG Sale Price by the KG Buyer.

KG, located in Hiroshima, was built in January 2004 and comprises 50 residential units and 8 parking units. It contributed about 0.9% (or approximately JPY 38.5 million) of Saizen REIT's annual revenue in the financial year ended 30 June 2010 ("**FY2010**").

Given the small size of KG relative to the entire portfolio of Saizen REIT, the Current Divestment is not expected to have any material impact on the financial position of Saizen REIT.

### **Consideration**

The KG Sale Price was fully paid up by the KG Buyer on 8 March 2011. The entire proceeds from the Current Divestment will be used for partial repayment of the loan of YK Shintoku (the "**YK Shintoku Loan**").

The KG Sale Price was arrived at on an arm's length basis, taking into account, *inter alia*, the KG Valuation (as defined below) and the prevailing market conditions.

### **Property value and financial results**

Based on a desktop valuation of KG prepared by Success Solution Inc., an independent valuer commissioned by the Manager, KG was valued at JPY 419.0 million (S\$6.4 million) (the "**KG Valuation**") as at 31 December 2010. The KG Sale Price therefore represents a discount of approximately 6.9% to the KG Valuation.

In the past 12 months, YK Shintoku and YK Shingen, another TK operator of Saizen REIT, had completed the divestment of 14 properties, namely Patios Ohashi (announcements dated 21 September 2010 and 30 September 2010), Sun Park Yokokawa (announcement dated 29 September 2010), Funairi Honmachi 54 (announcement dated 29 September 2010), Residence II Yasuda (announcement dated 29 September 2010), Matoba Y Building (announcement dated 29 September 2010), Villa Kaiganchō (announcement dated 8 October 2010), Higashi Hakushima Y Building (announcement dated 14 October 2010), Otemachi Y Building (announcement dated 14 October 2010), Kinyacho Y Building (announcement dated 14 October 2010), Kamei Five (announcements dated 21 October 2010 and 28 October 2010), Jewel Town Suehiro (announcement dated 9 November 2010), Reef Suite (announcements on 15 November 2010 and 24 November 2010), K1 Mansion Morioka (announcements on 24 January 2011 and 28 January 2011) and Aistage Ushita Minami (announcement on 25 February 2011) (collectively, the “**FY2011 Divestments**”).

## **Financial effects**

### **Net asset value per Unit attributable to Unitholders (“NAV per Unit”)**

Based on the audited financial statements of the Saizen REIT Group for FY2010 and assuming that the Current Divestment and the FY2011 Divestments had been completed on 30 June

### Earnings per Unit ("EPU")

Assuming the Current Divestment and the FY2011 Divestments had been completed on 1 July 2009 and based on the audited financial statements of the Saizen REIT Group for FY2010, the estimated aggregate pro forma financial effects which the Current Divestment and the FY2011 Divestments would have on the EPU of FY2010 are as follows:

### Rationale

Since the YK Shintoku Loan went into maturity default in November 2009, the asset manager of Saizen REIT has been working closely with the loan servicer on a suitable course of action. To this end, the loan servicer has proposed the progressive and partial sale of YK Shintoku's properties to reduce the absolute amount of the YK Shintoku Loan. Such reduction in absolute amount of the loan will likely make its refinancing more acceptable to potential lenders.

### Remaining loan balance

The original balance of the YK Shintoku Loan was JPY 7.953 billion (S\$122.4 million). The application of (i) net sale proceeds totaling JPY 2.2 billion (S\$33.8 million) from the divestments

of 18 properties of YK Shintoku and (ii) operational cash flow of YK Shintoku of JPY 0.4 billion (S\$6.2 million) towards loan repayment had reduced the balance of the YK Shintoku Loan to JPY 5.4 billion (S\$83.1 million) as at the date hereof. Following loan repayment from sale proceeds of the Current Divestment, the remaining balance of the YK Shintoku Loan is estimated to be approximately JPY 5.1 billion (S\$78.5 million).

Taking into account applicable cash reserves of JPY 0.4 billion (S\$6.2 million) maintained by YK Shintoku under the loan agreement, the net outstanding loan of YK Shintoku amounts to approximately JPY 4.7 billion (S\$72.3 million).

### **Interest of Directors and Controlling Unitholders**

A divestment fee of 0.3% of the KG Sale Price as well as each of the FY2011 Divestments as previously announced (collectively, the “**Divestment Fees**”) is payable to the Manager. The Divestment Fees will be payable in the form of cash or units or a combination of both (as the Manager may in its sole discretion determine).

Save for the above Divestment Fees, none of the Directors or controlling shareholders of the Manager, or the Manager, the Trustee or controlling unitholder of Saizen REIT, as the case may be, has any interest, direct or indirect, in the Current Divestment.

### **Relative Figures Computed pursuant to Rule 1006 of the Listing Manual**

The relative figures for the Current Divestment and the FY2011 Divestments taken in aggregate and computed on the bases pursuant to Rule 1006(a) to 1006(d) of the SGX-ST Listing Manual (based on the recently announced audited financial statements of the Saizen REIT Group for FY2010) are as follows:

The aggregate figures of the Current Divestment and the FY2011 Divestments under Rules 1006(a), (b) and (c) exceed 5%, but not 50%. Accordingly, the Current Divestment and the FY2011 Divestments, in aggregate, constitute a discloseable transaction as defined in Chapter 10 of the SGX-ST Listing Manual.
