NEW LOAN FROM MIZUHO BANK, LTD

The Board of Directors of Japan Residential Assets Manager Limited, the manager ("**Manager**") of Saizen Real Estate Investment Trust ("**Saizen REIT**"), is pleased to announce that Godo Kaisha ("**GK**") Tosei has entered into an agreement (the "Loan **Agreement**") for a JPY 700.0 million (S\$11.3 million¹) loan (the "Loan") from Mizuho Bank, Ltd ("**Mizuho**") on 29 June 2012. The Loan has been fully disbursed.

Use of proceeds	Proceeds from the Loan may be deployed towards Saizen REIT's working capital and/or for property acquisitions.
Covenant relating to change of management	Mizuho's prior written consent (acting reasonably) is required for (i) the resignation of Mr Arnold Ip Tin Chee as chairman of the Manager and/or a director of the Asset Manager; and (ii) the resignation of Mr Yutaka Matsunaga as president of the Asset Manager.

The Loan is the third loan that the TK operators of Saizen REIT have obtained from Mizuho. The Management Team is pleased that Saizen REIT is able to build on and strengthen its banking relationship with Mizuho.

² While the Loan is subject to a variable interest rate, GK Tosei has entered into an interest rate swap arrangement to fix the annual interest rate on the Loan throughout its term at 2.81% commencing from 3 July 2012.

³ Based on property valuations performed as at 27 February 2012 and 1 April 2012.

⁴ Under the Loan Agreement, the asset manager of Saizen REIT, KK Tenyu Asset Management (the "Asset Manager"), will act as a guarantor for the Loan. In return, the Asset Manager will charge GK Tosei an annual guarantor fee (the "Guarantor Fee").

Following the drawdown of the Loan, Saizen REIT's gearing (aggregate leverage ratio)⁵ and net gearing⁶ will be 32% and 25% respectively.

Save for the Guarantor Fee, none of the Directors or controlling shareholders of the Manager, or the Manager, HSBC Institutional Trust Services (Singapore) Limited (in its capacity as trustee for Saizen REIT) or controlling unitholder of Saizen REIT, as the case may be, has any interest, direct or indirect, in the above-mentioned loan transaction with Mizuho.

Net borrowings is equal to total borrowings less net cash (ie. cash at bank plus deposit with cash management agents less current rental deposits, other current liabilities and current tax liabilities).
