V-Nee Yeh is considered to be the beneficial holder of more than 20.0% of the issued share capital of HC Capital Limited ("HCL").

As a consequence of the purchase of 2,500,000 units in Saizen REIT on 17 May 2013 by HCL, V-Nee Yeh's deemed interest has increased from 11.992% to 12.168%.

V-Nee Yeh's deemed interest in the units immediately before the transaction has changed from his previous notification on 24 April 2013 due to open market purchases by HCL. However, no notification was made as the transactions did not result in a percentage level change (rounded down to the next whole number).
