Further to Saizen Real Estate Investment Trust's ("**Saizen REIT**") announcement on 4 November 2014, the Board of Directors of Japan Residential Assets Manager Limited, the manager of Saizen REIT (the "**Manager**"), is pleased to announce that the divestment of High Grace II was completed on 21 November 2014.

The sale price of High Grace II is JPY 366,450,000 (S\$4.0 million¹) and a deposit of JPY 18,000,000 (S\$0.2 million) was received on 4 November 2014. The remaining sum was received on 21 November 2014.
