ASMHL is the beneficial holder of more than 50.0% of Argyle Street Management Limited ("ASML") and ASM Connaught House General Partner Limited ("ASMCHGP"). ASML is the beneficial holder of more than 20% of the voting shares of ASM Asia Recovery Fund ("ASMARF"), ASM Hudson River Fund ("ASMHRF") and other ASM funds. ASMARF is the beneficial holder of more than 50% of the issued share capital of ASM Asia Recovery (Master) Fund ("ASMARMF"). ASMCHGP, being the general partner of ASM Connaught House Fund LP ("ASMCHF"), manages, controls the operation of and determines the policy with respect to ASMCHF.

As a consequence of the disposal of units in Saizen REIT by ASMARMF, ASMHRF and ASMCHF, V-Nee Yeh's deemed interest has decreased from 13.102% to 12.966%.
