NOTICE OF TERMINATION OF SAIZEN REAL ESTATE INVESTMENT TRUST ("SAIZEN REIT" OR THE "TRUST")

We refer to the trust deed dated 27 September 2007 constituting Saizen REIT as amended and/or supplemented from time to time (the "**Trust Deed**").

Pursuant to Clause 26.2 of the Trust Deed, Japan Residential Assets Manager Limited, being the manager of Saizen REIT (the "Manager") has, among others, the absolute discretion to terminate the Trust if the net asset value of all the assets held or deemed to be held upon the Trust is less than S\$50 million after the end of the first anniversary of the date of the Trust Deed or any time thereafter, provided that it gives notice in writing to all Unitholders and to Perpetual (Asia) Limited (in its capacity as trustee of Saizen REIT) (the "Trustee") not less than three (3) months in advance of the termination. Given that the current net asset value of the assets held or deemed to be held upon Saizen REIT as of the date of this notice is less than S\$50 million, the Manager has, after consultation with the Trustee, recommended that the Trust be terminated accordingly.

As required under the Trust Deed, we hereby give Unitholders notice of termination of the Trust. Trading of Units in Saizen REIT is suspended as at the date of this notice of termination, being 16 May 2017.
